Buyer Beware:

Florida does not license mold remediation (or mold assessment) companies, as they do General/Building contractor companies — only individuals. It takes only 14 hours of online study to obtain a Florida Mold Remediator (or Assessor) License. Capabilities vary widely. A mold license is no guarantee of quality. Consider not only the remediation company's rating but most importantly the credentials and experience of the proposed job supervisor. Are they licensed and insured? Check here.



Carefully Evaluate to Protect Yourself:

Secure three quotes to evaluate cost and services offered. The quote should be simple, with minimal jargon, and easy to understand. Confirm that the price is fixed. Confirm the name and license of the proposed job supervisor. Use the Decision Matrix Table below to compare proposals.



Reputation:

Search and review firm ratings and recommendations (Angi & Google.) Confirm legacy.



Mold Removal:

Confirm that mold will be removed and not simply covered up /painted over. Make sure that they will provide pictures before, during, and after the work. And that the work will include post remediation air sampling to verify that the remediation work has not left the home cross contaminated.





Biocides:

Ensure that work will be green, chemical free. No biocides. No chemical residue.




Insurance Claims:

Warranties/Guarantees:

Mold free? Irritation free? 2-year warranty/guarantee for the work

Emergency Dry-Out?

If Emergency Dry-Out is needed, call your Insurance Carrier to provide the name of a recommended dry-out contractor. That way the Carrier is responsible if drying does not properly restore. Take pictures of the work — including the machines and people. Then call us. You do not have to use Carrier supplied remediators no matter what they or your policy seems to say. Nor are Caps applicable once the Carrier sends or refers the dry-out contractor.
